MEMBERSHIP APPLICATION

I the undersigned, on behalf of my firm, present this application to the Board of Directors of the Arkansas Asphalt Pavement Association for consideration of membership. If the Board of Directors accepts this Membership Application, the undersigned agrees to be governed by the Association's Bylaws, Rules, Procedures and Dues Structure and will cooperate with other members toward the advancement of the Association's purpose and objectives.

MEMBERSHIP CATEGORIES: (SELECT ONE)

- ASPHALT PRODUCERS** – Persons, firms, organizations and corporations who operate a hot-mix Asphalt plant that meet the requirements of the Arkansas Highway & Transportation Dept. **Dues:** Initial fee: \$250.00 (applied toward Maximum Annual Dues). **Annual Plant Fee:** \$500.00 for each asphalt plant producing asphalt materials that will be used in Arkansas during the calendar year. **Monthly Production fee:** \$.04 per ton (based on English measure) for all Asphalt materials produced or used in Arkansas during the preceding month. Minimum monthly Production Fee of \$100.00. Minimum Annual Dues: \$1,200.00 Production Fee + Annual Plant Fee. Maximum Annual Dues: \$15,000.00 (includes Initial Fee, Plant Fee and Production Fee). *
- AGGREGATE PRODUCERS** – Persons, firms, organizations and corporations not engaged in the production of hot-mix asphalt, which operate quarries, pits or borrow areas that meet the requirements of the Arkansas Highway & Transportation Department. **Dues:** Initial fee: \$250.00 (applied towards Annual Dues). **Annual dues:** \$3,000.00 *
- ASPHALT REFINERS / MERCHANDISERS** – Persons, firms, organizations and corporations who refine and/or merchandise asphaltic cement. **Dues:** Initial Fee: \$250.00 (applied towards Annual Dues). **Annual Dues:** \$7,000.00 *
- ASPHALT PAVING LAYDOWN & SEALING CONTRACTORS** – Person, firms, organizations and corporations not engaged in the production of hot-mix asphalt or mineral aggregates, who are asphalt paving contractors, qualified as bidders of recognized governmental agencies. **Quarterly Production fee:** \$.02 per ton (based on English measure) for all Asphalt materials used in Arkansas and \$.005 per gallon of Chip and Seal installed in Arkansas. **Dues:** Initial Fee: \$250.00 (applied toward Annual Dues). **Annual Dues:** \$600.00. Maximum Annual Dues: \$2,000.00 (includes Initial Fee, Asphalt and Chip and Seal) *
- ASSOCIATE SUPPLIER MEMBERS** – Person, firms, organizations and corporations who sell or otherwise make available equipment, materials, and special services, all relating to the production and construction of hot-mix asphalt. Special services shall include, but not be limited to, trucking, insurance, testing laboratories, safety, finance, and designing. **Dues: Annual Dues:** \$1,000.00 *
- ASSOCIATE MEMBERS** – Person, firms, organizations and corporations who sell or otherwise make available equipment, materials, and special services, all relating to the production and construction of hot-mix asphalt. Special services shall include, but not be limited to, trucking, insurance, testing laboratories, safety, finance, and designing. **Dues: Annual Dues:** \$400.00 *

* **Dues** shall be due and payable upon admittance of membership and annually on **January 15th** thereafter.
